

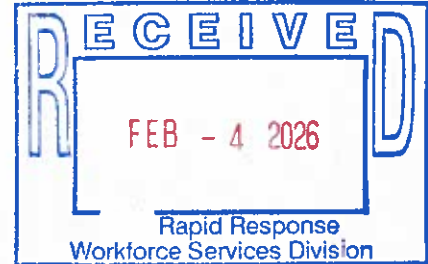

To whom it may concern –

This letter is being issued pursuant to the Federal Worker Adjustment and Retraining Notification Act (WARN) to inform you that GMRI, Inc. d/b/a Bahama Breeze (the "Company") will permanently close the restaurant located at: 2714 Potomac Mills Circle, Woodbridge, VA 22192.

Please find attached/enclosed the communication that was given to all team members regarding the closure. The restaurant will be closing permanently on April 5, 2026. As of January 27, 2026, there were 62 individuals employed at this location. It is not yet known exactly how many impacted team members there will be as the Company is offering transfer opportunities to other locations. But out of an abundance of caution, the Company opted to comply with the WARN provisions. These team members occupy the primary positions of General Manager (one), Restaurant Manager (three), professional (one), server (23), bartender (five), expeditor (one), busser (one), host (eight), line cook (10), production cook (four), utility steward (four), and silverware roller (one). Employees do not have bumping rights and are not represented by a union.

I have reviewed the information contained in this letter and believe it to be accurate as of the date of this letter. Additionally, I have the authority to represent GMRI, Inc. with respect to information provided in this letter.

Dear Bahama Breeze Team Member –

The Company - GMRI, Inc. dba Bahama Breeze - has made the difficult decision to close the Bahama Breeze restaurant located at 2714 Potomac Mills Circle, Woodbridge, VA 22192. Please know that this closure is not a reflection of the hard work and contributions you made every day in providing an exceptional Caribbean inspired experience for our guests. Rather, the decision was made based on the operating environment at and around this location. After the Company explored strategic alternatives for the Bahama Breeze brand, it opted to permanently close certain locations and convert other locations to other brands owned by the Company. Due to the operating environment, this location will not be converted. The restaurant will be closing on April 5, 2026.

Your entitlement to severance pay and opportunities to transfer to other brands owned by the Company will be discussed with you in the coming days. No team member has a right to claim another position within the Company over any other team member. At this time, this layoff is permanent.
