[Sector Strategies and Career Pathways Academy \(SSCPA\)](#) - The Sector Strategies and Career Pathways Academy (SSCPA) is a statewide initiative to provide professional development for Virginia's workforce professionals to further operationalize career pathways and sector strategies in the Commonwealth. The Academy consists of two components:

- **Academy:** In-person class and online curriculum that explains the “what,” “why” and “how-to” of sector strategies and career pathways.
- **Community of Practice:** An online forum/website where Virginia's workforce professionals and stakeholders can share practical experiences, tools and emerging best practices.

[United States Department of Labor Employment and Training Administration \(USDOLETA\)](#) - The Employment and Training Administration (ETA) administers federal government job training and worker dislocation programs, federal grants to states for public employment service programs, and unemployment insurance benefits. These services are primarily provided through state and local workforce development systems.
