
DOL Monitoring Report: Average Participant Duration


Exit Date: July 1, 2017 to March 31, 2019






PY 17 Work Experience Expenditures as of May 31, 2019




Quarter 3 – Youth Participation Trends PY16 through PY18

Quarter 3 – Youth Participant Data Comparison for PY16, PY17 & PY18







PY 18 Adult Expenditure Status as of May 31, 2019




WIOA Title I Adult Participation Trends Quarter 3 PY16, PY 17 & PY18








WIOA Title I Dislocated Worker Participation Trends PY16, PY 17 & PY18




PY 2018 Impacted Employees by LWDA


PY 2018 Impacted Businesses by LWDA


Open Cases: Impacted Employees


PY 2018 Impacted Businesses by NAICS Code


PY 2018 Employees Affected by


PY 2018 WARN vs. Non-WARN Layoffs




Business Services Data

 - 263,959 businesses in Virginia (PY 2017)
- 16, 681 Total Services provided
 - A service is only counted once, even if the same service is used multiple times
 - Ex. If a company uses Workforce Recruitment services twice, we only count it once on the report


Type of Service Provided
